**Snoqualmie Ridge “Mancation” Golf Getaway Combines  
Exclusive Nicklaus Design with Pacific Northwest Retreat at Salish Lodge**

**Snoqualmie, Wash. (May 10, 2018)** — The new “Snoqualmie Ridge Golf Mancation” package, available in partnership through The Club at Snoqualmie Ridge and Salish Lodge & Spa, is an ideal way for the guys to play the only Jack Nicklaus Signature Course in Washington State and relax at the luxurious Salish Lodge.

The “Snoqualmie Ridge Golf Mancation” package includes 18 holes of golf at The Club at Snoqualmie Ridge, host course of the PGA TOUR Champions' Boeing Classic; golf cart, access to practice facilities and complimentary cigar (redeemable at The Club at Snoqualmie Ridge Gift Store); one night stay at Salish Lodge & Spa; \$75 credit for dinner at The Dining Room at Salish Lodge; and two 22 ounce bottles of Pike Hive Five Salish Lodge & Spa Hopped Honey Ale.

The iconic Salish lodge & Spa overlooks Snoqualmie Falls and provides a quintessential Pacific Northwest experience. Each of the newly-renovated 85 guestrooms is a luxury retreat of its own. All have gas fireplaces, spa-like showers with dual showerheads or oversized soaking tubs, and many have views of the Snoqualmie River.

Tee times are not available on Monday or Friday and are subject to availability. Resort fee of \$20 per night includes valet parking, wireless high-speed Internet access, bottled water in room, day passes to Mt. Si Sports + Fitness, morning coffee and tea from 7-11 a.m., and afternoon tea from 4-6 p.m. in the Salish Ballroom Foyer.

Located in the foothills of the Cascade Range, 25 miles east of Seattle, The Club at Snoqualmie Ridge is part of the Arcis Golf collection of 60 golf clubs and courses nationwide.

Sculpted from stunning terrain in the shadows of the Cascade Mountains, the par-72, 7,264-yard Nicklaus layout weaves through dense stands of towering firs, with wide fairways and perfectly conditioned greens, plus picturesque water features and panoramic mountain views around every turn.

The course has multiple tees to engage golfers of all abilities. Adding to the allure, players share the course with an array of indigenous wildlife species. There's even an eagle sanctuary located on the 14th hole.

Renowned for its memorable mountain golf, luxurious amenities, and extraordinary service, The Club at Snoqualmie Ridge also features a beautiful contemporary-style clubhouse as the ideal destination for dining and socializing.
