



**MIKE SCULLY SELECTED AS GENERAL MANAGER

A former college and pro football offensive lineman, Scully comes to Reynolds Lake Oconee from Desert Mountain Club, a prestigious private club in Scottsdale, Ariz., where he was Director of Golf the past six years. Scully and wife Kristie have two sons, Peyton and Jack. Mike also has an older daughter, Taylor.
