Villa del Palmar Beach Resort & Spa is a luxury destination resort on the Sea of Cortez, off the eastern coast of the Baja Peninsula. This centerpiece of the resort is [TPC Danzante Bay](#), part of a luxury master-planned community adjacent to the coastline of Baja's inland marine sanctuary. A Rees Jones design, the golf course offers five sets of tees, ranging between 4,916 and 7,237 yards. It features wide fairways and greens that must be carefully judged but are never unfair. Most of the entrances to the greens are open—allowing approach shots to run on safely—while the holes along the cliffs feature strategically placed collection areas to keep errant shots from taking the plunge into the blue water below.

Villa del Palmar at The Islands of Loreto is a luxury destination resort on the Sea of Cortez, off the eastern coast of the Baja Peninsula overlooking Danzante Island.
